

On June 16, 2014, with seemingly little fanfare, the Burlingame City Council passed a voluntary Historic Resources Ordinance. Since at least the 1970s, many Burlingame residents have felt that some type of preservation ordinance would be desirable. The building boom following WWII gave rise to the demolition of many historic buildings and a heightened awareness of our nation's history around the time of the bicentennial in 1976 made many Burlingame residents nostalgic for what had been lost. Indeed, the birth of the Burlingame Historical Society in 1975 was rooted in awareness that our history and sense of place were literally being dumped and our past, disappearing. Last month, our city council took steps to address those concerns.

In a nutshell, the new voluntary program adopted last month provides incentives for owners to preserve historic properties by offering attractive tax benefits, reduced permit fees for remodeling and use of an Historic Building Code. Only properties that meet certain criteria and are within a very limited geographical area of the downtown (El Camino to Anita Road and Peninsula to Oak Grove) are eligible under the new ordinance. These potential benefits can simplify, and make more financially attractive, adaptive reuse of and improvements to properties that would otherwise have difficulties meeting current building standards. Property owners must apply for coverage under the new ordinance; applications will be processed through the Planning Department and Commission. An initial professional survey conducted in 2007-8 (required by CEQA laws as part of the Downtown Specific Plan) identified several properties that would be eligible for the new ordinance, though others may also apply. DID YOU KNOW? The S.S. Coxe: This ship has sailed!

Last month, (June 2014) after spending 43 years in Burlingame's Sanchez Channel, the S.S. General Frank M. Coxe was towed by its new owners to Stockton. Our archivist emeritus, Martha Rosman May, loved that ship, which was built the same year she was born. Martha May tells us the ship's story here: "The Sherman Restaurant in the historic 91-year-old S.S. General Frank M. Coxe closed its doors early in 2010, approximately two years after opening. Built as a 150-foot river steamer in 1922 in West Virginia for the Army Quartermaster Corps, the S.S. Coxe was sent to San Francisco to serve as a harbor transport for Army personnel and their families between mainland SF and the island forts around the Bay. After being decommissioned from the Army in 1946, the S.S. Coxe became a scenic cruise ship in the Bay until 1955, when it steamed under full power to Stockton to become the "Showboat." In 1958, the ship was towed to Oakland and soon continued as the "Showboat" in Jack London Square. In 1971, it was towed to Burlingame where it housed nine different restaurants in 43 years. The ship was in Burlingame longer than any other location."

to two pioneer residences of early Burlingame: The George W. Gates residence (on Donnelly) and the James and Jessie R. Murphy Residence (on Douglas Avenue). Both of these homes had been rolled off Burlingame Avenue around 1917 and moved to their current locations, as the once residential Burlingame Avenue became increasingly commercial.

If the new Historic Resources Ordinance is successful, it may eventually be expanded into residential neighborhoods. In other communities similar programs have proved to be quite popular and effective in preserving a community's historic resources and sense of place.
